Board Speaker: Mr. Narasayya Aadam has the proposal to put up the bill to demand remarks about the same. He should present it.

Proposal was not presented.

Mr. Narasayya Aadam (Solapur City South): Hon. Speaker, I am going to present only two points on the bill.

There is discontent in the people about the DSP Mr. Sagar involved in Khairlanji matter, so D.Y. S. P. has been transferred. Mr. Sagar has come on deputation. Shrikrishna Commission was appointed to conduct judicial enquiry about the Mumbai riots. 900 people got killed in those riots. No actions are taken by the government about the recommendations done by the appointed Shrikrishna Commission in concern to the occurred incident. I have also given information about the Parbhani matter to Hon. Dy Chief Minister. Main accused in that matter hasn't been arrested yet. Therefore, if the Hon. Dy Chief Minister can explain about these questions, then I will get satisfied.

Mr. R. Patil (Home Minister): Sir, a labour leader got beaten up at Parbhani. On getting this information from the Hon. Member a squad was detailed yesterday itself, and five accused in this matter have been arrested by today's noon. All accused along with the main shall get arrested. No accused in the matter will be left free. Actions taken about the recommendations of Shrikrishna Commission would be explained in tomorrow's discussions on Law and order answering. Information pertaining to the actions already taken by the government and which are ongoing would also be given.

Also, the honourable member has brought forward the point pertaining to Kharilanji incident. I want to state in regards to the incident that, the senior officers investigated the matter again and again. Presently the case has been given to CBI. Also, I want to state about Mr. Sagar that he is from backward class, I had received information about his excellent work, therefore ...

Mr. Narasayya Aadam: Speaker sir, Honourable Mr. Balasaheb Ambedkar himself told me that, I am from the same cast of which the Superintendent of police is from. Therefore, the matter pertaining to this superintendent of police may be brought into the knowledge of the Hon. Home Minister and ask him to transfer his services.

Mr. R. R. Patil (Home Minister): Sir, I will also speak to Honourable Mr. Balasaheb Ambedkar and find out what different information he has about the Superintendent of Police. If it is found to be factful, then action would be taken against this Superintendent of Police.

Sir, the bill presented in the house is very small. As per the provisions of the previous bill, in order to prohibit the dangerous acts, authority to confine were delegated by Home Department to District Collectors on district levels and to Police Commissioner on Commissioner's office level.

This causes accused to get undue advantage and they get bail. If those powers are delegated for six months instead of three months then the government would be in position to take review. Also there would be no need to delegate powers after every three months. This bill is been presented to have only this amendment. Therefore, my request to the house to pass this bill unanimously.

Board Speaker: The second proposal for sending the bill to the joint committee is from Hon. Member Mr. Girish Bapat, Mrs. Madhuri Misal and Mr. Sanjay Bhegde. One of them should present the same.

Board Speaker: Now there will be a combined discussion over proposal for disapproval of bill, question pertaining to taking the bill into consideration and proposal to send the bill to the joint committee. Thereafter, after the answering of the minister firstly the proposal about disapproval of bill will be put up for polling. After it gets disapproved, the proposal for sending the bill to the joint committee will be put up for polling. If that gets disapproved, the question for taking the bill into consideration will be put up for polling.

Mr. Devendra Fadnavis (Nagpur South – West): Speaker sir, I am standing to present my thoughts about the L. A. bill No. VII of 2009, a bill further to amend the Maharashtra Prevention of Dangerous Activities of Slum-Lords, Bootleggers, Drug Offenders and Dangerous Persons Act, 1981.

Speaker sir, through this bill, you are giving rights related to expel or banish the personnel doing video piracy. In this Maharashtra whenever there are huge crimes are occurring under the MPDA law vide different laws, at that time no one comes forward to give witness against the criminals. The criminals involved in such crimes get released by some or other reasons. For that, in order to take preventive action upon them, while we expel them then we are adding up one more category through this bill. Earlier there were only slum-lords, bootleggers, drug offenders and dangeruous persons in this category. But now we are adding up the personnel carrying out video piracy into it. Really it is a correct factor, and is appreciable. Speaker sir, while putting up this bill I am going to put forward only two things. It is relentlessly found that the people on whom we take action vide MPDA law, it is many a times done to have political revenge. These actions are taken by having close relations with S.P., D. C. P., with motive to take revenge against political opponents or about a particular case/matter. At such times, the high court makes many orders to expel null and void related to MPDA and passes strictures upon us. Therefore, by virtue of this, it is needed that the government should give assurance of one thing, that while taking action of expelling, the given norms should be strictly followed upon. The government also gets stricture. The government expels someone, he /she goes to court and the court cancels the banishment, and passes strictures upon the government. Therefore, if someone has to be expelled or banished then it has to be thoroughly checked that whether the offences done are of that serious nature or not and then only appropriate action should be initiated.

Secondly, only making of law against the video piracy will not be fruitful. We see many such CD seller near Mantralaya. Speaker sir, if you go to any person on the Amdar Niwas road or to the further road, you can find the sale of pirated CDs is still going on. Don't we have laws for that? They are there, but no action is taken. In Mumbai and Nagput it is going on without any hurdle. In Variety chowk you can find pirated CDs are openly sold. If we have law pertaining to it and then also we are not taking action is not correct. Even after the provision of MPDA if our system does not take action upon them then this provision will remain as it is. In the rights you have taken, you apply MPDA on only exhibition and not on the sale of the pirated material. Exhibition means they are distributing such kind of CDs. MPDA is applicate whoever is exhibiting. However, the one who is sitting to sell or consistently selling or openly selling through shops, may be applied with this law. Therefore, you should think in this way also, that the word 'sale' should also be put in. MPDA should be applied upon the seller as well. In future times, you should not keep mum that this law is in this form. Through this law, such mentality would surely finish and we won't be seeing the pirated CD sellers while going from Majestic Amdar Niwas to Gateway of India. Speaker sir, if you give such assurance to the Police then only this law will prove beneficial. The law is good, there is no doubt. Hastiness has been shown to bring upon the ordinance therefore resolution of disapproval has been given here. My only request is that henceforth, no need of issuing such ordinance, just bring them directly to the house and get them passed, now I finish my short speech.

Mr. Girish Bapat (Kasba Peth): Speaker sir, I have one suggestion in regards to the bill. We are making new addition pertaining to expelling and banishing. The Hon. Home Minister is also present here. I had experience at Pune, that after issuing the order to expel by Pune's CP, someone approaches us and requests whether something can be done about the same. But the person who has been expelled, he tells that nothing has happened, so you don't have to worry. I will go to the Mantralaya and get it done. Speaker sir, I will give you many such examples. We are creating soft fields by making new rules. If you want to thrust different categories in this then you should think upon it without fail. I can understand about the court putting stay. Not on the Mantralaya level, but on administrative level, there are examples of many expelled of Pune city are getting stay. You should check it without fail and if your don't find them, I will give you. The law should not be misused. I have told many a times, before the law is made, it's shortcut or bypass is already found. If you would be allowing such short cuts then there will be no meaning to such law. Law should be such, that no one can utter a single word upon it.

# A BILL (AMENDMENT) FOR PREVENTION OF DANGEROUS ACTIVITIES OF SLUM-LORDS, BOOTLEGGERS, DRUG OFFENDERS AND DANGERUOUS PERSONS

#### [Mr. Girish Bapat]

If you are allowing shortcuts while making the law and the personnel against whom it is actually made get escaped and by mistake someone gets involved, then he has to face the action of getting banished. You should take care that this law should not be misused. I only have this much to speak in this regard and finish my speech. Thank you!

Mr. Sudhir Mungantiwar (Ballarpur): Speaker Sir, Hon. Home Minister has brought this bill for discussion. Entire house has respect about Hon. Minister Mr. R.R. Patil. There is no doubt that he has made this bill thoughtfully and upon complete study.

Speaker Sir, in this event, I want to ask only two question to Hon. Home Minister. I request that he should answer them during his speech.

Speaker sir, take action against slum-lords, bootleggers, drug offenders and dangeruous persons as per Maharashtra Prevention of Dangerous Activities of Slum-Lords, Bootleggers, Drug Offenders and Dangerous Persons Act, 1981. However, it should not happen that those who sit on road side for selling, they are generally poor, no action should be done upon them. Instead, the place where these CDs are procured, and those who are distributors of the pirated CDs, should be dealt upon. The CD sellers on the road side earn Rs. 40-50 a day, they are poor, unemployed, if actions is taken upon them then no one will even come forward to give bail.

Speaker sir, the second subject is that, the bill states that it is required to pump up new energy in the film industry. If such nature's law get passed, then the film industry will get energized. However, until and unless there is change in the story structure of the films till then, I don't thing new energy will get pumped up and no one will turn up to see the movies in cinema halls. Movies of current time it is seen that extremely short clothing, in some movies totally no cloths, and body exposure is going on. During earlier times monks used live on single undergarment, and if the actress are going to expose like them, then no fresh energy will get created even after extreme efforts by the government. If soft minds are going to get cultured in such fashion then new energy would not get pumped into the film industry. The government should take care that no ill effect should take upon the mind of gentleman like Hon. Member Mr. Girish Bapat.

Speaker sir, the government has taken decision that cinema halls would be made available 30 days a year for Marathi movies. Cinema halls like INOX have a per person rate of 350 to 400 for each movie. Therefore, if at all good Marathi movies are to be picturized then strict compliance of the decision taken by government, should be done. I finally request Hon. Home Minister to explain in this regard, and finish my speech.

Mr. Ramesh Bagwe (Minister of state for Home Affairs): Speaker Sir, discussion is going on in this house on L. A. bill No. VII of 2009, a bill further to amend the Maharashtra Prevention of Dangerous Activities of Slum-Lords, Bootleggers, Drug Offenders and Dangerous Persons Act, 1981...

Adv. Ashish Jaiswal: Speaker Sir, I only want to request that in virtue of the bill that our expectation is that instead of taking action against the sellers, it should be initiated against the makers.

Mr. Vijay Shivtare: Speaker sir, there is huge contamination of milk is going on in the state. Therefore necessary action should be taken against the contaminators.

Mr. Ramesh Bagwe (Minister of state for Home Affairs): Speaker Sir, contamination of milk is a different issue. This bill has got no concern with it.

Speaker Sir, due to video piracy generally transactions of Rs. 1500 crores take place in the cine world each year. Due to this piracy loss of 30 to 35 percent i.e. 400 to 500 crores take place. Revenue earned vide Entertainment tax and VAT gets loss of 100 to 150 crores. Therefore, the need of this law has come up.

Speaker sir, as told by the Hon. Member Mr. Devendra Fadnavis and Hon. Member Mr. Girish Bapat, there is no provision to expel in this. For such criminals there is provision of 1 year confinement. If we have to punish as per this law, then as per copyright act, 1957 before any breach of copyrights related to movie or sound recording, there should be atleast one charge sheet filed against this person and the court should have taken due consideration of such offence. Punishment of 6 months to 3 years has been proposed in this. Also penalty of Rupees 50 thousand to 1 lakh has been also proposed. This bill has been presented so that the public arrangement in the society should not get hampered and the criminality gets prohibited. Hence I request the honourable house members to pass this bill.

Mr. Sudhir Mungantiwar: Speaker sir, no answer has been given by the Hon. Minister sir about each cinema hall has to show Marathi movies 30 days a year.

Mr. R. R. Patil (Home Minister): Hon. Speaker, the rule pertaining to this is that, each cinema hall has to show Marathi movies 30 days a year. I have received complaint for Marathi Movie Producers. I had taken joint meeting with movie producers and owners of the cinema hall. In that meeting, the owners of the cinema halls showed readiness to make their halls available for Marathi movies. Speaker sir, at some places the distributors are not ready to take on the movies. At some places Marathi movies are not watched. Second reason

is that such time slots are given for those movies when Marathi movie lovers may not turn up. Evening show time slots are not given to them. Afternoon show times gets allotted. For solving the issue of not getting show time of the evening slot, I had formed a committee and instructed them to solve the issue within yourselves by sitting together. Rights pertaining to this were given to the Marathi Cinema producers. It was decided to act as per their disclosure. What has happened regarding this, that I have to check up. On behalf of the government I give the statement to the house that the multiplex theatres, cinema theatres who have the demand of making them available for a month in a year for Marathi Cinema shows then they should do accordingly, otherwise the relies given to them in entertainment tax would be cancelled.

## About reduction suggestions for Appropriation Bill

Mr. Devendra Fadnavis: Speaker sir, Hon. Minister of Parliamentary Affairs is present in the house. My request to him is that, earlier on the day there used to be session for Appropriation bill, the reduction suggestion on Appropriation Bills were accepted till one hour prior to session for Appropriation bill. Now the new rule has been made that those should be submitted till five o' clock of the previous day, many of the hon. Members may not be aware about it because they are new members. My request to Hon. Minister sir, that this new rule may not be applied at least for this convention. Hon. Members remain functional for the whole day. This rule is not known to us. At least for this convention, earlier instructions related to Appropriation Bill may be applied. The new rule made in this regard may be made applicable next convention onwards. The circular issued in this convention has not reached to many honourable members. The house has the rights to accept on the basis of exception.

Mr. Harshvardhan Patil: Suggestion of the Honourable member is correct, however the change has been incorporated in the rule book pertaining to changed rule. At this stage it won't be appropriate to do so. At the time of Function Advisory Committee meeting, this subject can be discussed.

Mr. Devendra Fadnavis: Speaker Sir, the house has the rights to accept on the basis of exception. In spite that it has come into the rule book, the house has the rights to change it. We work in the house for the whole day. In exceptional condition we can take decision and there is no reason to have any kind of hurdle about it. We many a times relax the rules. The honourable speaker sir has the right to relax the rule. I accept that the information which was required in this regard is not found. I was in the house for the whole day. I have not gone anywhere to roam. The honourable speaker sir and the house have the rights to make exception to the rule, therefore this suggestions may be accepted till tomorrow, suggestions of two three honourable members <illegible> the new rule may be made applicable next convention onwards. There will be no hurdle due to this about suggestions to be given for Appropriation Bill.

Mr. Harshvardhan Patil: Speaker sir, it is your right to deal in this. As a member, we don't have any objection to it. If it is to be accepted as an exception then it could be. You have already mentioned this in the rule book. We always get co-operation from the honourable member Mr. Devendra Fadnavis.

Mr. Devendra Fadnavis: Speaker Sir, since now you have given consent to this by accepting our confession of being in fault, the house should take decision.

Board Speaker: Okay.

Mr. Sudhir Mungantiwar (Ballarpur): Speaker sir, with your permission I bring forward half and hour discussion on the following subject vide rule 94

"104 lift irrigation schemes in 10 districts of Vidarbh are operational on co-operative basis and the funding required for this scheme has been taken as loan by the farmers on 17 to 18 percent rate form District Central Bank. For the reasons of the amount of this loan is Rs. 40 crores, the said scheme has got trapped in loan and interest jumbling, the scheme is not getting looked after well, almost all lift irrigation schemes are in shut down condition. Since those lift irrigation schemes are in shut condition and no water supply to the field, the participant farmers of this scheme are in debt. If the Vidarbh Irrigation Corporation undertakes all these lift irrigation schemes, 65000 acre land will get coverage of irrigation and around 50 thousand farmers will get benefitted.
